Please note that submissions received for the second and third rounds will be awarded if resources permit.

Travel expenses include all air and ground transportation and will be reimbursed as follows:

Traveling From (to a maximum of):

British Columbia \$500

Those who are traveling by car will be reimbursed for mileage at \$0.40 per kilometer to a maximum of \$300.

b. Hotel accommodations (to be shared by up to four students per room) for three nights [Note – extra nights, either preceding September 27 or following September 30 are the responsibility of the student]; Billed accommodations may be available pending local CLF member support.

c. Scheduled meals and beverages at CLF events;

d. Conference Guide and hand-outs.
